The PSPRS FY2025 Fourth Quarter Newsletter was given to the members prior to the meeting for their review. Chairman Simmons asked the board if they had any questions regarding the newsletter. The board members had no questions.

Current Events: Mrs. Ogden asked the secretary when an employee separates employment after attending an Academy, are they required to repay the Sheriff's Office? The secretary advised that the Sheriff's Office has a Training Reimbursement Agreement. If an employee resigns prior to the one (1) year after being off field training, then the employee is required to reimburse the Sheriff's Office. She further explained if the Office terminates the employee, then the employee is not required to reimburse. Chairman Simmons asked if the same applied to Patrol. The secretary advised, yes, however, it's two (2) years after being off field training. Additionally, she advised the reimbursement is usually their final paycheck (hours physically worked and remaining PTO hours) and the maximum amount for reimbursement is \$10,000. CORP tuition is approximately \$6,000 and PSPRS is higher. This amount doesn't include the employee's salary or the instructors' salary. The local board had no further questions and/or comments.

The next quarterly meeting was scheduled for June 10, 2026 at 3:30 p.m., unless a special meeting is needed for a potential return to work.

The meeting was adjourned at 4:09 p.m.
