Special Meeting.

Friday March 16th 1866. 2. P.M.

Pursuant to Notice the Board met
at the day and hour above mentioned:

Present, J. B. Dow Esq. Chairman,
W. A. Werninger Esq. and
Ch. H. Brinley Clerk ~~by his Deputy J. B. Dow~~
forming a majority of the Board. —

The minutes of the last meeting were
read by the Clerk, and approved:

Thereupon A. F. Waldemar Esq. appeared
and presented his appointment as Supervisor
duly issued by his Exc. the acting Governor,
in place of Thomas Hughes, resigned. —
On motion W. Waldemar was duly sworn
by C. H. Brinley Esq. ~~Clerk of the Board by~~
~~his Deputy J. B. Dow~~, and the official oath
duly filed, whereupon A. F. Waldemar Esq.
took his seat, making a full Board
present. —

The Board hereupon took into considera-
tion the appointment of a suitable person
for the office of Sheriff. —

On motion of Supervisor W. A. Werninger
Esq. Nominations for the office of Sheriff
were declared to be in order by the Chairman:

W. J. Flower was nominated by Supervisor
W. A. Werninger Esq., and no other nominations
being made, the Board proceeded to vote for
the appointment of Sheriff. —

W. J. Flower Esq. was unanimously

lected by the Board, and it is hereby ordered:

That W. J. Flower Esq. is hereby appointed Sheriff of Yuma County:

And it is further ordered

That the Clerk inform W. J. Flower of his appointment.

On motion of Supervisor W. A. Werninger the Board proceeded to the appointment of County Treasurer:

The Chairman of the Board declared nominations for County Treasurer to be in order. Whereupon Supervisor W. A. Werninger nominated Robert Coles Esq. for the office of County Treasurer:

No other nominations being made the Board proceeded to the election of County Treasurer:

Robert Coles was unanimously elected, and it is hereby Ordered:

That Robert Coles Esq. be and is hereby appointed County Treasurer for the County of Yuma:

And it is further ordered:

That the Clerk of the Board inform the said R. Coles of his appointment.

Whereupon the Clerk laid before the Board a communication from J. T. Alsop Territorial Treasurer, and from R. C. McCormick Acting Governor.

The Communications were duly considered and it is hereby ordered:

That the Clerk transmitt by letter to the Hon: J. T. Alsop, Territorial Treasurer the information desired, and that the letter of the said J. T. Alsop be filed with the official papers of the Board:
