From The Sentinel of Nov. 1:

On the night of Sunday, 28th ultimo, six prisoners confined in the jail at this place, made their escape. Their names, and the crimes for which they were convicted, are as follows: Wm. Gertrude, assault with deadly weapon. This is the man who murdered the woman in Prescott several years ago; Patrick Lany, convicted of murder at Cerbat, Mohave county; Canuto Soto, murder in second degree; **Que-cha-qua, murder in second degree**; Jas. McGuire, misdemeanor; and John Maynard. Five prisoners declined to escape, although the way was left open for them. The escapes all crossed the Colorado and some of them were seen on the road toward San Diego. None were captured up to November 1. A hole was dug through the wall by which the escape was made.
