#### The Griffin Murder.

On Thursday last, 18th inst., A. Decker and H. Morgan arrived in town from Gila Bend. The latter named gentleman states that he was at the examination of Johnny McDonald at Phoenix, who was charged with the murder of Griffin. McDonald established his innocence, and was discharged. Our informant further states that McDonald and another party, (whose name is unknown) immediately started from Phonix for Wickenburg, and on the way were murdered, supposed by Iudians. It is further stated that two men are now in prison at Phoenix (one a Portuguese who has confessed to a knowledge of the crime), and the officers are in pursuit of a third one, the trio being charged with the murder of Griffin. Griffin's knife, (which was indentified) was traded off by one of the accused party to the packer at Camp McDowell. these statements are correct, and the authority is considered reliable, the culprits are pretty sure to receive their just reward—a few yards of rope. The citizens on Salt River and vicinity appear determined that crime shall not go unpunished.

Steamer Nina Tilden, with Barge Black Crook, left here for ort Isabel on Thursday last.

Steamer Colorado is expected to arrive on the 23d or 24th inst., from Mohave, with 500 sacks cop-per ore from Williams' Fork en route to San Francisco per steamship Newbern.

One hundred and forty tons Galena ore, from Castle Dome, three hundred hides, and three hundred beaver skins are upon our wharf, and will forthwith be shipped to San Francisco.

GILA-BEND.-We are informed by Mr. Decker, a resident of the "Bend," that he has a ditch some fourteen miles in length, taken from the Gila, which supplies a volume of water sufficient to irrigate several thousand acres. He assures us that there are at least 25,000 acres of superior arable land in that valley, and that no fears need be entertained relative to its productiveness on account of a scarcity of water, as 'he require-ments of that entire valley can be furnished at a comparatively nominal figure. In our next we shall give some of the topographical features of this favored valley.
