Location of Incident: 2700 block of West 5th Street – Yuma, AZ

Update #2:

On Friday, September 14, 2018 at approximately 10:00 a.m., Jimmie Jordan turned himself in to Investigators of the Yuma County Sheriff's Office. Jordan was arrested and booked on ten felony drug charges ranging from drug paraphernalia to narcotic sales.

Update #1 – September 12, 2018:

On Wednesday, September 12, 2018 at approximately 8:45 a.m., the Yuma County Sheriff's Office served a search warrant in the 8400 block of South Yavapai Lane in reference to the September 3rd homicide. The YCSO is currently searching for Jimmie Jordan, 19, of Yuma for questioning in this case. Jordan is described as a male, 5 feet 11 inches tall, 170 pounds, brown hair and brown eyes. Jordan is considered armed and dangerous.

Original Release – September 4, 2018:

On Monday, September 3, 2018 at approximately 1:22 p.m., the Yuma County Sheriff's Office received a report of a deceased person inside a home in the 2700 block of West 5th Street in Yuma.

Upon arrival, deputies located three deceased adult males inside the home with apparent gunshot wounds. The YCSO Criminal Investigation Bureau assumed the investigation and, with the assistance of the Yuma Police Department Crime Scene Unit, worked throughout the evening collecting evidence at the scene.

The victims have been identified as Grady Baxter, 20, of Yuma, AZ; Nicholas Grabbe, 19, of Yuma, AZ; and Javier Sanchez, 24, of Yuma, AZ. Next of kin notification has been made.

While we continue to search for a suspect(s) in this case, the YCSO does not believe this was a random event.
