Level 1 Sex Offender Notification Francisco Rodriguez

The Yuma County Sheriff's Office (YCSO) is releasing the following information pursuant to A.R.S. 13-3825, the Community Notification on Sex Offenders Law. The offender in this publication is living within Yuma County. It is the responsibility of the Chief Law Enforcement Office having jurisdiction where the offender resides to make notifications to the community. Notification must be made when certain sex offenders are released from the Arizona State Prison, accepted under an interstate compact or released from the county jail back into the community. Offenders are categorized into three levels: Level One (low risk to the community),

Level Two (intermediate risk to the community), and Level Three (high risk to the

community).

The individual who appears on this notification, Francisco Rodriguez, 54, has been convicted of a sex offense that allows for community notification. Francisco Rodriguez has advised the YCSO that he is residing at 358 E. San Felipe Street in San Luis, Arizona. He is described as 5 feet 6 inches tall, 189 pounds, with brown hair and brown eyes. He is not wanted by the Yuma County Sheriff's Office at this time.

On September 12, 2014, Rodriguez plead guilty to one count of Attempted Sexual Conduct with a Minor and one count of Sexual Abuse in the Yuma County Superior Court in Yuma, Arizona. He was sentenced to serve 10 years at the Arizona Department of Corrections, with credit for 357 days served prior to sentencing, and is currently under the supervision of the Yuma County Adult Probation Department for 15 years. His victim was a female juvenile known to him.

Francisco Rodriguez is considered a Level 1 sex offender with a low risk to reoffend.
