Level 2 Sex Offender Notification Jeffrey Edward O'Conner

The Yuma County Sheriff's Office (YCSO) is releasing the following information pursuant to A.R.S. 13-3825, the Community Notification on Sex Offenders Law. The offender in this publication is living within Yuma County. It is the responsibility of the Chief Law Enforcement Office having jurisdiction where the offender resides to make notifications to the community. Notification must be made when certain sex offenders are released from the Arizona State Prison, accepted under an interstate compact or released from the county jail back into the community. Offenders are categorized into three levels: Level One (low risk to the community),

The individual who appears on this notification, **Jeffrey O'Conner**, **36**, has been convicted of a sex offense that allows for community notification. Jeffrey O'Conner has advised the YCSO that he is residing at 13125 E. 51st Lane in Yuma, Arizona. He is described as 6 feet 5 inches tall, 250 pounds, with blonde hair and hazel eyes. He is not wanted by the Yuma County Sheriff's Office at this time.

On August 5, 2020, O'Conner pleaded guilty to one count of Lewd Conduct with a minor child under sixteen years of age in the Madison County Seventh Judicial District Court of Rexburg, Idaho. He was sentenced to serve 1 year and 11 months in the Idaho State Penitentiary. He is currently under the supervision of the Yuma Regional Parole Office. His victim was a male juvenile known to him.

Jeffrey O'Conner is considered a Level 2 sex offender with an intermediate risk to reoffend.
