Level 3 Sex Offender Notification Harrison Jody

New Address: 256 E. Spring Street, Space B – Somerton, AZ 85350

The Yuma County Sheriff's Office (YCSO) is releasing the following information pursuant to A.R.S. 13-3825, the Community Notification on Sex Offenders Law. The offender in this publication is living within Yuma County. It is the responsibility of the Chief Law Enforcement Office having jurisdiction where the offender resides to make notifications to the community. Notification must be made when certain sex offenders are released from the Arizona State Prison, accepted under an interstate compact or released from the county jail back into the community. Offenders are categorized into three levels: Level One (low risk to the community), Level Two (intermediate risk to the community), and Level Three (high risk to the community).

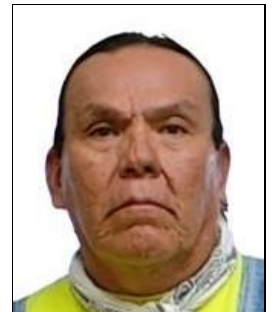
The individual who appears on this notification, **Harrison Jody, 47**, has been convicted of a sex offense that allows for community notification. Harrison Jody has advised the YCSO that he is residing at 256 E. Spring Street, Space B in Somerton, Arizona. He is described as 6 feet 0 inches tall, 200 pounds, with brown hair and brown eyes. He is not wanted by the Yuma County Sheriff's Office at this time.

On February 14, 2013, Jody was found guilty of one count of Sexual Abuse in the Maricopa County Superior Court in Phoenix, Arizona. He was sentenced to lifetime probation. His victim was an adult female known to him.

On December 3, 2013, Jody's probation was revoked and ordered to serve 2.25 years in the Arizona Department of Corrections, with credit for 302 days served for presentence incarceration.

Harrison Jody is considered a Level 3 sex offender with a high risk to reoffend.

This notification is not intended to increase fear; rather, it is our belief that an informed community is a safer community. The YCSO has no legal authority to direct where a sex offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he/she chooses. Citizen abuses of this information to threaten, intimidate, or harass sex offenders will not be tolerated. Sex Offenders have
